

TIMELINE FOR THE 206TH ANNUAL CONVENTION OF THE EPISCOPAL DIOCESE OF NORTH CAROLINA

Revised October 28, 2021

Thursday, March 1, 2021	Deadline for churches to file 2020 parochial reports. Canon 30.5.
Monday, May 3, 2021 (208 days before Convention)	The Secretary notifies churches whose number of lay delegates will change for the 206th Annual Convention. Canon 1.3.
Tuesday, June 1, 2021	Diocesan Council notifies each church of its Fair Share for the 2022 Mission and Ministry Budget. Canon 18.1. The Secretary provides forms for certifying election of lay delegates.
Thursday, June 17, 2021	Diocesan Council sets the dates for webinars on the tentative Mission and Ministry budget for 2022 and for Convocation meetings.
Thursday, July 15, 2021	Deadline for a church to request reduction of its Fair Share for 2021 or 2022. Canon 18.2.
June-July Meetings of Vestries	Vestries elect lay delegates to Convention for three-year terms and alternates for one-year terms.
Thursday, July 22, 2021 (129 days before Convention)	The Bishop certifies to the Secretary the list of clergy entitled to seat, voice, and vote in Convention. Canon 1.1.
Monday, August 2, 2021 (119 days before Convention)	Deadline for clerks of vestries to enter online certificates of election of lay delegates to Diocesan House. Canon 1.2.
Monday, August 23, 2021 (98 days before Convention)	The Secretary publishes the official roll of Clergy and Lay Orders of the 206th Annual Convention, gives formal notice of positions to be filled by election, issues instructions for submitting resolutions and nominations, and informs members of Convention about the appointment of Legislative Committees at Convention. Canon 1.2. Systems for online nominations and online indications of interest to serve on Legislative Committees are open.
September Meetings of Campus Ministries	Each campus ministry elects one lay delegate and one alternate to Convention (one-year terms).
Thursday, September 2, 2021	Deadline for churches to file 2020 audits with Diocesan House. Canons 17(f), 20.6(a), and 21.4(g).

Monday, September 13, 2021	<p>Deadline for lay delegates and clergy to volunteer for appointment to Legislative Committees.</p> <p>System for online submission of reports to Convention opens.</p>
Thursday, September 16, 2021	Diocesan Council adopts the tentative Mission and Ministry budget for 2022. Canon 18.6.
Monday, September 20 through Thursday, October 7, 2021	Webinars are offered to the Diocese describing the tentative Mission and Ministry budget for 2022.
Monday, September 20, 2021	The Secretary notifies churches that must apply to Diocesan Council for a waiver of Rule of Order III in order to retain vote at Convention.
Friday, October 1, 2021	<p>Deadline for youth to file applications with Diocesan House for placement on ballot as convocational youth delegates to Convention.</p> <p>Deadline for churches to apply for waiver of Rule III.</p>
Monday, October 11, 2021 (40 days before Convention)	<p>Deadline (noon) to submit nominations and resolutions. Rules of Order XXII and XXIII.</p> <p>The Bishop appoints Legislative Committees no later than today. Canon 13.2.</p>
Friday, October 15, 2021	Deadline to submit comments to Diocesan Council about the 2022 budget.
Monday, October 18 through Thursday, October 28, 2021	Convocations meet to discuss nominations and resolutions, to elect youth delegates and alternates for one-year terms, and to elect deans and lay wardens as required. Canons 19 and 44.
Wednesday, October 26, 2021 (30 days before Convention)	Deadline to apply to the Secretary for admission into union with Convention as a parish or mission. Canon 2.5.
Thursday, October 21, 2021	Diocesan Council approves the 2022 budget for presentation to Convention. Diocesan Council considers applications for waiver of Rule III.
Friday, October 29, 2021	Deadline for officers, commissions, committees, and other entities to submit reports to Convention.

Monday, November 1, 2021	Deadline to submit a Certification of Change in Election to Diocesan House.
Friday, November 5, 2021	The Secretary issues voting credentials by email.
Tuesday, November 9, 2021 (10 days before Convention)	The Secretary strikes from the voting rolls clergy and lay delegates from churches that have not paid in full their Fair Shares for the period October 1, 2020 through September 30, 2021. Canon 18.4.
Thursday, November 18, 2021	An online form is opened for Floor Nominations (also called Late Nominations).
Saturday, November 20, 2021	<p>Delegates and clergy are asked to log into Zoom and to vote in the quorum call at the Election Runner website beginning at 8:30 am.</p> <p>The deadline to submit the electronic form for Floor Nominations and to submit Floor Resolutions (also called late resolutions) by email to the Secretary is 9:15 am.</p> <p>Convention begins at 9:30 am.</p>

Convention will be held online and broadcast from St Mark's, Wilson.
